

Preliminary remarks

- NFDI4Earth probably the largest consortium of the NFDI
 - 1 Applicant
 - 10 Co-applicants
 - 22 Participants (with funding from 2022)
 - 26 Participants (currently without direct funding)



- correspondingly high coordination and communication effort
 - Establishment of the coordination office since October 2021
 - step-by-step coordination, first with the co-apps (later on with participants via task areas)
 - Networking within the NFDI association (overview of and participation in various bodies)
- On-boarding by a series of partner meetings since December 2021 to
 - ensure the embedding of all partners at staggered intervals
 - introduce the context and NFDI resp. including the cross-cutting activities / sections as well as
 - the NFDI4Earth and its complex structure and manifold activities (TAs, IGs, Expert Groups, ...)






NFDI Consortium Earth System Sciences






Our Governance (according to the proposal – BLV)


Our Governance (according to the proposal): Plenary NFDI4Earth



- encompasses all representatives of the participating institutions (Co-Applicants and Participants)
- meets at least annually
- proposes and admits new members and decides on membership terminations
- nominates and elects six members for the steering group (for annual term, reelection possible, ...)
- elections by circulation procedure
 analogous to the election of the spokesperson

Implementation of the Governance: Steering Group





- is formed by the spokesperson (as chair) and co-spokespersons as well as six members elected from the plenary
- coordinates and 'monitors' the work of the TAs and decides on any necessary adjustments
- usually meets once a month (currently or usually virtually)
- -> constituted in summer 2022

 (after 1st election possibly at and after plenary session resp.)



Implementation of the Governance: Advisory Board





- reviews the status, strategy and development of NFDI4Earth from an external perspective
- provides recommendations for the steering group on the content and achievement of the project goals
- meets at least once a year
- consists of nine members (incl. a speaker) who cover the breadth of ESS
- The Steering Group will appoint four members of the Advisory Board and the Plenary five additional members.





Current activities

- Developing a common architecture for NFDI4Eearth Software Products in close cooperation with all TAs
- Reviewing (and testing) potential open-source software solutions, i.e. implemented by other NFDIs
- Setting up a continuous integration und continuous delivery environment (CI/CD) for NFDI4Earth developer teams
- Participate in NFDI Sections/Working Groups (e.g. Search & Harvesting, Data Integration, Semantic Interop., TF Tools for Project Management, DMPs, Guidance & Best Practices, ...) -> adaption after team is completed
