

- Deliver position paper, standards, ...
- 4 Sections established in 2021:
 - Common Infrastructures (section-infra)
 - Ethical, Legal and Social Aspects (section-ELSA)
 - (Meta)data Terminologies and Provenance (section-metadata)
 - Training & Education (section-edutrain)
 - All 4 Sections published initial concept papers
 - Sections are open to new NFDI members see more under <u>https://www.nfdi.de/sections/</u>





Basic Services !?!

A service is a technical-organisational solution, which typically includes storage and computing services, software, processes and workflows, as well as the necessary personnel support for different service desks.

- NFDI-wide basic services would have the potential to serve most or all consortia
- Target group is the wider NFDI-community and, in particular, operators of specialised community resources



Base4NFDI: Basic Services across NFDI Consortia


- Scientific Domains organized in NFDI consortia
- Leading infrastructure providers are already part of these consortia
- Consortia in unique position to determine fit-for-purpose services for RDM support




- Common, interoperable basic services are core to deliver on promise of integration and long-term operational models
- Joined linkage into EOSC and further international infrastructures
- All NFDI consortia agreed upon and joined in Base4NFDI

Base4NFDI - Key Deliverables

- Framework for user-driven and quality-assured basic service development
- Agile process to establish a NFDI-wide basic service portfolio
- Up to 10 fully established basic services starting with:
 - Identity and Access Management Service (IAM)
 - Persistent Identifier Service (PID)
 - Terminology Services (TS)
- Building on existing solutions and complementing EOSC






Base4NFDI: Development of basic services in a 3-Stage Process

- Flexible Funds allow to adapt to organizational/technical dynamics and technical complexities
- Will enable development and roll-out of substantial number of services
- Will help to ensure integration in diverse existing landscapes by supporting adoption

Base4NFDI decides embedded in the NFDI Association and with different perspectives

- A Technical Expert Committee (TEC) assures infrastructural expertise and commitment
- In each phase the services' readiness is evaluated by the TEC and the Consortia Assembly
- A set of decision criteria, templates and dossiers will support/document decisions and feedbacks



Base4NFDI - Path to sustainability

- Base4NFDI contributes to successful NFDI evaluation through basic services that
 - support interoperability and integration across domains
 - are ubiquitous in RDM and heavily used by consortia
 - avoid double funding and help achieving synergies and cost savings
 - are operated reliably in the NFDI service portfolio, many as part of EOSC
 - are prime example for NFDI-wide collaboration
- Future coordination can be transferred to NFDI Directorate

Base4NFDI - A challenging timeline

- 2022 February: DFG call for proposals
- 2022 March: Lol Base4NFDI sent to DFG
- 2022 April 29th: Joint proposal of Base4NFDI initiative submitted
- 2022 May 11th: Base4NFDI presentation to NFDI Scientific Senate
- 2022 May 23rd: Defense of the proposal in front of reviewers' board
- 2022 June-November: Base4NFDI preparing for basic service initialization of IAM Services, PID Services and Terminology Services
- 2022 November: Decision on funding by Joint Science Conference
- 2023 January: Start of the Base4NFDI project (for 5 years)
